



For the last 30 years, the fisheries of Espiritu Santo National Park have been dramatically declining, and now there is almost nothing left. (As dramatically shown in the video below.)

The current management plan, drafted after the Park's inception in 2007, does not provide needed protection for the reef ecosystem in the Park, with less than 2% of the Park fully protected. The remaining 98% of the Park is open to nets and traps, along with sport fishing and spearfishing. By this definition, Espiritu Santo National Park is a "paper park" (ie, a park in name, but not in practice).

Our goal is to protect 100% of the inshore reefs of the Park through modifications to its current management plan.



Phase 1 of our project (the public consultation process) is almost complete and in record time, and the draft management plan will be released early in 2024 for public review.

In spite of promises made by CONANP's park director to add protections and remove fishing gear types, we are very concerned that there will be no new protections for the inshore reefs and all the current types of fishing gear will still be allowed.

We anticipated this outcome and will now begin Phase 2 of our project, a \$70,000 multimedia communication campaign to create strong public support and advocacy for change, modeled and run by the team who ran the successful campaign to protect whale sharks in the Bay of La Paz.

The team will lead a grassroots social media campaign called "Espiritu Santo: Donde estan los peces?" This campaign will be combined with posters, alliance building presentations, a major documentary video and much more.

In addition, SeaWatch will fund a scientific paper on where the Park ranks in the index of "paper parks" in the world, led by expert Dr. Veronica Relano. Finally, SeaWatch will be challenging the IUCN green listing awarded to

Espíritu Santo National Park, as well as CONANP's mandate to manage the Park sustainably as required under Mexican law.
